  - b. Fish Stocking Strategy look for interest from Dixie Lake fishing enthusiasts
  - c. Oakland County Healthy Lakes Initiative/CLMP Mike
    - i. Secchi Disk Transparency Checks being conducted by Mike through September (minimum 8) Depth clarity measurements from 5 to 13 feet so far this year.

- ii. Aquatic Weed Survey Wednesday 17. July (Nik, Huron River Watershed Council) No new weed species were discovered. Lots of the old ones.
- iii. September Phosphorous samples to pulled & frozen, then submitted in October.
